



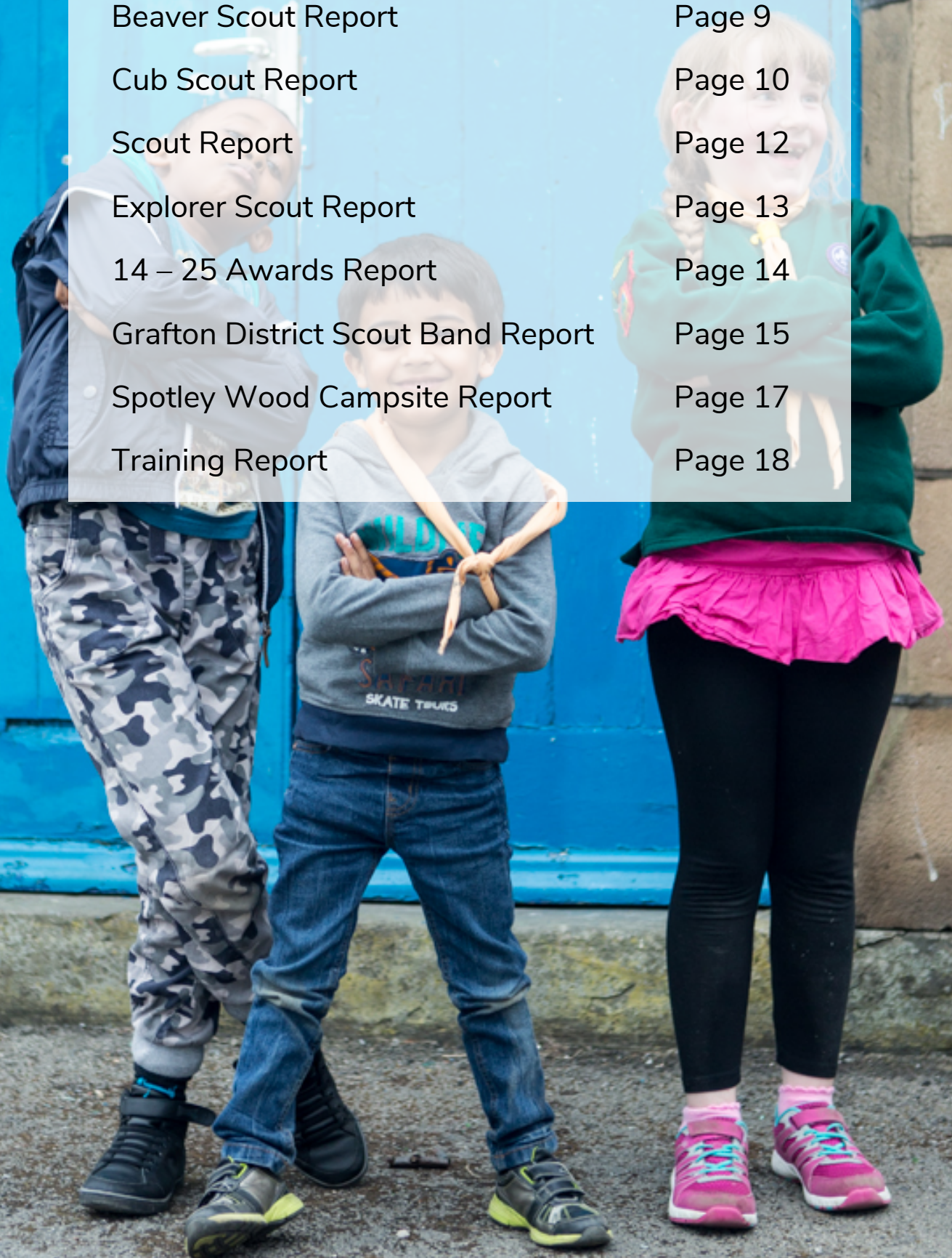

Firstly, I would like to thank the District Executive for their continued support over this challenging year. To Will my Deputy for all your support over this last year and for all your efforts in the organisation of both our camps and badge day supported very ably behind the scenes by Tyler Jeffs. To all of the ADCs for your input and support in the virtual District events and in supporting the Groups and your leaders through the past twelve months it has been a great team effort which has shown the District at its best.

I have been completely inspired by both young people and adults throughout the District over this period in time. We still face many challenges ahead, but I am more confident than ever that having come through the events of the last year we can emerge stronger and better than before. None of this is possible without the contribution of our amazing volunteers and I cannot thank you enough for all that you have done over this last year to keep inspiring the young people in our District, whether you are an Occasional helper, Executive Member, Leader or Parent never underestimate the influence that you have on equipping our young people with skills for life and building those lasting friendships which in challenging times will be invaluable.

As we move forward this year, we need to focus on ensuring that we support all our adult volunteers as we return to a more normal situation and that we also recognise the impact that the pandemic has had not only on our adult volunteers but also on our young people.

We have seen neighbours who had previously had little to do with one another come together and communities supporting those most vulnerable, and we must learn from this as we move forward together.

Our new DESC, Thomas N, is also most welcome. Norman P, who has a long association with Grafton has also decided to step down, but we are honoured that he has accepted a new role as our President. Ken U, our Treasurer, has continued the reorganising of the finances and making sure that the money we have, is placed in accounts that are more beneficial and easier to operate than the old ones. In his role as Spotley campsite warden he has also made sure that it has benefited from the lockdown and restart grants available as well as suggesting some positive changes on the site.

In my role as Chair, I have attended as many other appropriate scout meetings as I can via webinars or Zoom, which has been extremely useful, and I have learnt much

from these meetings. I am very aware that recruitment of new volunteers is vital at this time and District will do all it can to support groups in this.

Thank you to all on the Executive for the support you have shown me. I am aware I have not mentioned everyone individually on the Executive in this report, but all of you are valued for your time and the contribution you make to Grafton Scouts. In my last report I mentioned that the expertise and enthusiasm of each of the members of the District Executive and the local Group Executive committees will get us through the problems that may lie ahead, and I am confident that this is still the case. I continue to look forward to being part of these teams and to help with all that needs to be done. I hope that by next year's AGM all of you in District will be enjoying a much more normal way of running your groups.

Financial Review 2020-21

The District Finances are in a very secure position with Year End Reserves at £69887.

Capitation charges of £37730 were collected from Groups and Explorers £1875 for 2021. £39783 was remitted to County (£39602 in 2020) to cover Headquarter and County fees.

The surplus for the year shown in the accounts of £364. The deficit for the General Fund was £4074. The 2020 total surplus was £8812. The deficit could be attributed to the Covid 19 pandemic which resulted in little face to face scouting and activities taking place and significant costs to set up and run virtual events in order to support Scouting in the District.

The Spotley Campsite was closed all year.

The District Band had income of £147 and expenditure of £588, they were not able to meet or attend any events during the year.

Badge sales amounted to £1581 (£7502 in 2020) with costs of £2203 (£6192 in 2020). There are £96 of unpaid invoices which will be chased up. The stock has decreased to £3076 (£4105 in 2020) which is as we aimed to do and was a great achievement.

The 2 District Explorer Units Tunnel Rats and Jaguars have generated total income of £1530 and expenditure of £3844. Again they were not able to meet during the year but at least a nominal amount was collected as subscriptions to cover membership fees.

Gift aid was successfully claimed for the previous year of £1198.

The District managed to obtain grants totalling £8573 as part of the UK government support to organisations which had to close due to COVID 19. Some of this will be spent on further facilities at Spotley.

The new Group at Paulerspury has not been able to meet but managed to obtain a grant from the Recovery fund to enable them to be self-sufficient hopefully from now.

With District Reserves standing at £69887 well above the suggested reserve level of £40,000, the Executive Committee is committed to utilising the surplus reserves

over the coming years to promote growth across the District and to further enhance the support provided by the District Team members.

Although the District does not have sufficient funds to invest in long term investments it can look at obtaining the best interest possible on instant access or short term notice accounts. Interest gained this year was £167 at 0.5% as funds were transferred to a better yielding account.

Money was collected for the group but so many villagers came out with thanks and praise for the enjoyment this event had given them.

The new year brought very much of the same with seemingly no let up from the pandemic so virtual life carried on

In March we had a Virtual District Cubs Party with over 50 young people joining in the fun and entertainment.

In April we had our second District Virtual Cub Camp with 119 Cubs registering. As leaders, we had learned a lot from the first camp and I feel this one was easier all round. Again, many badges were earned and around 80 Cubs logged on and enjoyed the Magician/Juggler during the Saturday afternoon.

One of their tasks was to decorate an Easter Hat/Bonnet/Basket and the winner to receive an Easter Egg. All seemed easy on paper but a very difficult job to decide on a 'winner' from the evidence of the entries. These were whittled down to five, so two had Easter Eggs and the other three had large bars of chocolate. I delivered these one evening and I found it very humbling receiving the thanks from parents for the 'amazing camp' the District Team had organised.

As I said last year, I am very proud of all my leaders for the amazing work they have done during these strange and difficult times, running Zoom meetings and doing their utmost to keep the interest of their young people going. Without them, their helpers, parents and the young people, we would not be the District we are.

I would also like to take this opportunity to thank everyone who has helped and given me support by attending DCSL meetings and running their Packs so well.

I look forward to being able to visit to see you Face2Face again, very soon.

I would just like to thank the leaders for all the time and hard work you've put in over the last year – we know it's not been easy but we, and the young people and their parents, really appreciate it.

Grafton District Scout Band Report

March 2020

The last f2f meeting of the Band was the middle of March 2020 and then lockdown.

April 2020 onwards

The Band have not been able to meet and play together all year due to the pandemic lockdowns. In June Claire Shrubbs resigned as Bandmaster and left Scouting.

Three of the Band Leaders met in July and decided that the Band should continue and a proposal was put to the DC which was accepted and in September, Roy Cooper was appointed Acting Bandmaster.

When the lockdown 1 was lifted, f2f meetings for Scouting were allowed. We submitted two very detailed risk assessments via the CC, Dean Smith into the formal system. One to be able to meet at Blisworth to play/rehearse, the other for the Remembrance Day wreath laying at Roade. Details were agreed after very helpful discussions with the local British Legion and the school in Roade. The Remembrance Day event did get approval and we were planning this prestigious occasion, only for it to be cancelled a few days before when lockdown 2 happened.

Permission to play at Blisworth was refused despite heroic attempts by the DC, Ruth, and CC, Dean to get HQ to understand and accept that there are entities within Scouting that aren't just single age groups. HQ would not accept any situation involving wind or blowing instruments despite reference to Brass Bands England's agreement with the **Department of Digital, Culture, Media and Sport (DCMS)**. Therefore, we have not been able to meet f2f and play.

We did manage to have 9 Zoom meetings from October up to Christmas. We tried all playing together at the same time. The resultant 'sound' was recorded. On playback it was difficult to recognise the tune even though we knew what it was. We settled for individuals playing to backing tracks while on mute. This was OK for Christmas carols and we did manage to all get to the end of each tune together.

The numbers attending these meetings only ranged from 4 to a maximum of 8.

The Band have not attended any events during the year.

All accounts for 2020-21 are up to date with copies of balance statements supplied and agreed with the District Treasurer.

We continued with Zoom meetings in January but with less than 10 participating and not being f2f it was difficult to achieve satisfactory progress and keep interest. We made the decision to suspended Zoom meetings and wait until f2f Scouting and permission to play blown instruments was allowed. This was not an easy decision.

April 2021 ongoing

We now have our risk assessment for indoor playing approved and will be returning to Blisworth on Sunday afternoons from 6th June.

We will be having a recruitment drive by circulating information to all Groups within the District in July ready to re-energise the Band in September.

The Band will have lost nearly 18 months but hopefully will re-invent itself and will once more be an asset to the District.
